

Official Sweepstakes Terms & Conditions

#WonderFoldHalloween Sweepstakes

1. The WonderFold Wagon #WonderFoldHalloween Sweepstakes (the “Sweepstakes”) is sponsored by WonderFold Wagon.
2. Official Rules: These are the official rules (the “Official Rules”) for the Sweepstakes. By entering any of the Sweepstakes, Entrants agree that they can be contacted by email regarding the Sweepstakes, and to be bound by these Official Rules and all decisions of WonderFold Wagon relating to the Sweepstakes, which shall be final and binding on entrants.
3. Sweepstakes Period: The Sweepstakes is a month long sweepstakes in which two (2) eligible Entrants will be awarded either a \$100 cash gift card (grand prize) or all stroller wagon accessories for their current model that they own (as described in more detail below). Sweepstakes will commence at 12:00 p.m Pacific Standard Time (“PST”) on September 30, 2019, and end at 11:59 p.m. PST on November 3, 2019 (the “Sweepstakes Period”). All entries received during the Sweepstakes Period are eligible to win. WonderFold Wagon reserves the right to modify, extend, suspend or terminate the Sweepstakes in its sole discretion with or without cause. WonderFold Wagon’s computer is the official clock for the Sweepstakes.
4. How to Enter: NO PURCHASE, PAYMENT OR SUBMISSION TO SALES PRESENTATIONS NECESSARY TO ENTER OR TO WIN. Entrants should first visit <https://bit.ly/2lflwWa> .

To enter, you must access the WonderFold Wagon Halloween webpage below. Entrants must find the “WonderFold Halloween” tab. Entrants then should submit their photo in the entry form on the page. The submission allows one entry into the sweepstakes. To receive an additional entry, the entrant must post their costume on at least 1 social media platform (Acceptable platforms: Facebook, Instagram, Twitter, Youtube, or Pinterest), tag our account, and use the hashtag #WonderFoldHalloween. Entries may not contain, as determined by the WonderFold Wagon, in its sole discretion, any response or comment that: is sexually explicit or suggestive, violent, or derogatory of any ethnicity, race, gender, religion, profession, or age group, or is profane or pornographic; promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), promotes any activities that may appear unsafe or dangerous, or promotes any particular political agenda or message; is obscene or offensive, or endorses any form of hate or hate group; defames, misrepresents, or contains disparaging remarks about other people or companies; contains copyrighted materials owned by others and used without permission; contains materials identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead, without

permission; and/or violates any law. Instagram are not sponsors, do not endorse, and are in no way affiliated with the Sweepstakes. All entries become the property of WonderFold Wagon and will not be acknowledged or returned. WonderFold Wagon is not liable for entries that are lost, late, misdirected, incomplete, garbled, incompletely received, mutilated, or illegible, for any reason. Limits: There is a limit of 2 entries per Entrant for the entire Sweepstakes Period. All Entries become the property of WonderFold Wagon and will not be acknowledged or returned.

5. Determination of the winner: WonderFold Wagon will conduct two (2) random prize drawing from all eligible entries received during the Sweepstakes Period. One (1) grand prize winner will be randomly selected. There will also be one (1) 2nd prize winner randomly selected. A Provisional Winner will be selected on or about five (5) days after the end of the drawing (the "Drawing Date"). The Provisional Winner will be notified by email or Direct Message and will need to confirm they are the winner. If the Provisional Winner does not respond within seven (7) days of the date appearing on the prize notification, or fails to comply with the instructions contained in the prize notification within that time period, WonderFold Wagon reserves the right to randomly choose an alternate winner from the pool of remaining eligible entries. The first eligible Provisional Winner that WonderFold wagon successfully contacts in person by email or Direct Message and who claims the Grand Prize in accordance with these Official Rules will be declared the final Winner. The Winner may waive the right to receive a prize. The return of any prize, Winner's affidavit/release or prize notification as undeliverable will result in disqualification, the forfeiture of all interest in the prize, and selection of a substitute Winner from among all remaining eligible entries. The Winner may be required to provide evidence of identity in connection with claiming the prize. Non-winning entries will not carry forward to or be included in any subsequent sweepstakes or prize drawings of WonderFold Wagon.
6. Prize: There will be one (1) grand prize awarded a \$100 cash gift card. There will be (1) 2nd prize winner that will win all accessories for their current model. The retail value of the grand prize is \$100. The odds of winning a prize depend on the number of eligible entries entered into the random draw pool for the Sweepstakes Period. The grand prize will be mailed at no cost to Winner to the address provided by Winner when Winner claims the Grand Prize. Expect 7-14 business days for the gift card to be provided. The 2nd prize winner will receive all accessories at no cost to Winner to the shipping address provided by Winner when Winner claims the prize. Expect 7-14 business days for the accessories to be provided. No substitution of prize, including cash substitutions, will be permitted, except that WonderFold Wagon has the right in its sole discretion to substitute a prize of greater or equal value if the stated prize is not available. Prizes are not transferable. Prizes are awarded "as is" with no guarantee. all warranties, whether express or implied, including the warranties of merchantability and fitness for a particular purpose, are hereby disclaimed by the promotion parties. all prize details are at Wonderfold Wagon's sole discretion. any costs and expenses associated with prize

If required by law, WonderFold Wagon will issue a Form 1099 to the Winner for the approximate retail value of the prize. The Winner is solely responsible for all taxes (federal, state and local of all applicable jurisdictions) and all expenses not listed herein related to acceptance and use of the prize.
8. Permissions/Release: By entering the sweepstakes, the Winner agrees that WonderFold Wagon may use entrant's name, photo, and likeness for editorial, advertising and publicity purposes, including, without limitation, posting on WonderFold Wagon's website, without further compensation, except where prohibited by law.
